Summary evaluation with respect to the request for accreditation of the Bachelor Programme Public Administration and Governance and Master Programme Public Administration and Innovation — Ragnar Nurkse Department of Innovation and Governance, Tallinn University of Technology.

In consideration of the Self-Evaluation Report of the above programme, the Site Visit Report of 22 August 2023 of the EAPAA Site Visit Team for this programme, and the response of the programme to the draft of the Site Visit Report, the EAPAA Accreditation Committee, at its meeting of 5 September 2023 in Zagreb, Croatia, has evaluated this programme against the EAPAA Standards (version 2, September 2022).

Faculty	The faculty is very well qualified to teach the programme, when

Diversity	The diversity between teachers and students is proven. However, the extent of the involvement of students who do not speak Estonian well remains questionable.
Responsibility and	While the formal management structure is relatively clear and
autonomy	precisely defined, actual responsibilities are dispersed.
Supportive services and facilities	The university offers very good facilities to students.
Research basis	The contents of the courses are up-to-date and modified in accordance with recent research carried out by the teachers of these courses themselves.
Internationalisation	Internationalization is ensured by sufficient opportunities. However, while teachers make significant use of these opportunities, students are not adequately interested in them, and students' real use of these opportunities is insufficient.
